



# KOKATHA EDUCATION SCHOLARSHIP APPLICATION

## Who can apply?

Kokatha Members and registered Kokatha Common Law Holders or Children (Under 18) of KCLH who satisfy criteria

## How often will this run?

There will be 2 rounds every year. *You can only have one successful application per year.*

**Round 2, 2023 – 28/07/2023 until 23/10/2023**

## How much can I apply for?

Up to \$10,000

## What study costs can I apply for?

Fees, Textbooks/study materials, laptops, iPad, trade tools, PPE, accommodation costs, transport costs, trips that form part of curriculum, educational holiday programs, after school programs, uniforms, tutorial support.

## What is not covered?

After school care (OHSC), Childcare, Vacation care, Reimbursements

## Priority areas (applications will be prioritised to area 1 and 2 first.):

Area 1: University and Vocational Education

Area 2: Secondary High School

Area 3: Primary School (**Where Back -to-School funding cannot assist**)

Area 4: Early Childhood (0-Primary) (**Where Back-to-School funding cannot assist**)

## Criteria:

- An attendance record for the last 12 months for the education or training facility the applicant is currently attending.
- A character reference (from someone other than immediate family)
- An educational reference from an educational practitioner (e.g., teacher, lecturer)
- A personal statement from the student applicant (addressing reasons for applying)
- Most recent academic report
- Evidence of other (external) funding applications made.
- OPTIONAL – Explanation of any additional learning barriers, such as learning difficulties

## PROCESS:

**All completed applications must be received by the 23<sup>rd</sup> of October 2023.**

**Only completed applications will be forward on to the selection committee.**

You will be notified via phone or SMS of the outcome of your application.

All funds will be allocated direct to service providers and not the applicants in accordance with the KAC Rule Book.
