### **CRITERIA**

***Application and quotes must be included at the time of lodgment. Late quotes will not be accepted and incomplete applications will not be considered. Please complete the application form with a quote for one or more of the following:

### **Eligible Items:**

- Washing Machine and/or Dryer
- Fridge and/or Freezer
- Bed Frame
- Mattress
- Pedestal Fans
- Dining Table and Chairs
- Air Conditioners (**Note: ensure you have landlord's/SA Housing permission if renting and consider installation fees included in costs**)
- Lounges
- Chest of drawers or Wardrobe

### **What is not covered:**

- All other furnishings
- Microwaves and other small appliances
- Lighting fixtures

### **Important information:**

- You **MUST** be a Kokatha member or registered Common Law holder (you can check your membership by calling us or searching the public register for Kokatha at <https://www.oric.gov.au/> )

### **PROCESS**

- Submit your application with all quotes attached.
- It will be reviewed by the Trust Officer before review by the CEO.
- You will receive an e-mail or SMS of outcome (approved or declined)
- If approved payment may take up to 21 days due to high demand.
