



## SPECIAL CIRCUMSTANCES SPORTING CONTRIBUTION FUND

As of 2020, KAC has been able to create a new fund specifically to support Kokatha people to participate in significant sporting events that meet one or more of the following criteria.

- a national or international event
- related to an offer for a professional sports contract
- Kokatha representation as a participant within a national or international Indigenous sporting event

For individuals who satisfy the criteria a financial contribution of up to \$1000 can be made. The Corporation is unable to make payments to individuals however so all funds will be made to the most relevant supplier such as the sporting organisation.

Please note that this new fund is not attached to the KAC Charitable Trust and so approval of all applications that meet the criteria and provide all necessary documents listed on the application form will be made by the General Manager.

On receipt of a completed application including required documentation, you will be notified of the decision in writing within 14 days.
